By participating in the Drawing, each entrant unconditionally accepts and agrees to comply with and abide by these Official Rules (the "Official Rules"), and the decisions of A & B PROPERTIES HAWAII, LLC and ABP WAIKOLOA LLC ("Sponsor"), including the interpretation of these Official Rules, which will be final and binding in all respects. Eligible individuals (see ELIGIBILITY section of these Official Rules below) may enter the Drawing as defined below.
